

THE CORPORATION OF THE TOWNSHIP OF MADAWASKA VALLEY

BY-LAW NUMBER 2010-07

Being a By-law to appoint the Standing Committees for 2010 or until their successor(s) is/are appointed.

WHEREAS the Municipal Act S.O. 2001, as amended, Chapter 25, Section 8 (1) provides the powers to a municipality to enable the municipality to govern its affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues.

AND WHEREAS the Municipal Act S.O. 2001, as amended, Chapter 25, Section 9, provides that a municipality has the capacity, right, powers and privileges of a natural person for the purposes of exercising its authority under this or any other Act;

AND WHEREAS Council deems it expedient and necessary to appoint committees by By-Law to effectively and efficiently conduct and carry out municipal business.

AND WHEREAS related acts authorize the appointment of committees.

NOW THEREFORE the Council of the Corporation of the Township of Madawaska Valley hereby enacts as follows:

1. That the committees for the ensuing year, or until their successor(s) are appointed, be as follows:

DOCTOR RECRUITMENT: Phil Conway and John Hildebrandt

ECONOMIC DEVELOPMENT: Shelley Maika and Phil Conway

EMERGENCY PREPAREDNESS: Phil Conway

FIRE DEPARTMENT: Bonnie Mask and Sylvie Yantha

LIBRARY: Phil Conway

PARKS, HERITAGE and RECREATION: Phil Conway and Shelley Maika

POLICING: Sylvie Yantha.

2. That the following committees be operated as Committee-of-the-Whole, chaired by the Mayor and facilitated by a Vice-Chair as indicated in underlined bold:

COMMITTEE OF ADJUSTMENT: John Hildebrandt, Sylvie Yantha, Phil Conway, Shelley Maika and Bonnie Mask;

FINANCE: John Hildebrandt, Shelley Maika, Phil Conway, Bonnie Mask and Sylvie Yantha;

HUMAN RESOURCES: John Hildebrandt, Bonnie Mask, Phil Conway, Shelley Maika and Sylvie Yantha;

ROADS, PLANNING and PROPERTY: John Hildebrandt, Sylvie Yantha, Bonnie Mask, Phil Conway and Shelley Maika;

WASTE MANAGEMENT and WATER & SEWER: John Hildebrandt, Sylvie Yantha, Phil Conway, Shelley Maika and Bonnie Mask.

3. All Standing Committees / Committee-of-the-Whole be chaired by the Mayor and the Mayor is the ex-officio of each committee. In the absence of the Mayor the Vice-Chair as indicated in underlined bold will be the chair.
4. That all prior By-Laws dealing with Standing Committees / Committee-of-the-Whole are hereby rescinded.
5. That this By-law shall be deemed to have come into force and effect as of the date of passing.
